An innovative intervention for an important problem affecting adolescents in Kenyan schools. Abstract should be enhanced by:

Background- provide important statistics on burden of mental problems in Kenyan schools.

## Methods:

Please outline clearly- study population- include age, gender, number of people involved.

Study sites: Geographical coverage and number of schools and whether public or private.

Data collection methods: Distribution of participants per study method eg how many in survey, who and how many were involved in qualitative study.

Time- when was the study conducted, and duration. Eg how many weeks

Ethical consideration- who approved study.

Data analysis methods- what methods were used and software.

If cost effectiveness analysis was conducted, evidence on what data were collected and what outcomes were compared, otherwise bump off any reference to cost effectiveness- a health economics audience would expect costs and outcomes data.

Remove references from abstract.

Kenya school health policy and disability Act, should be embedded in the background to position the work.

Conclusions should align with methods and findings section- we should not have conclusions that are not grounded to prior information- for example There was no prior mention of costs of psychiatric services, so we cannot have conclusions referring to it.
